The Captains meeting was brought to order by Rocky Conn. Meeting minutes from the last meeting were read and accepted as stands.

Treasurer's report was not handed out since nothing changed since the last meeting. Jessica announced our Party will be on November 8th and that registration for Winter League will be November 10th at the Cork n Bull from 7 to 8 pm. You can register at the party but no registrations will be accepted after 8:00 pm on the 10th.

Ted Gay gave a report on the Qualifier status. At present we have 10men. Several women want to sign up so he has extended the time limit for 2 weeks to allow more people to sign up if possible. Please do so!!!! Important that this is done so the qualifying rounds may be played. He will post the final list at the cork n bull so you will know how and when this will be played out.

Marty Foote had nothing to report on Secretary Business.

Tami had nothing to report on except get your plaques turned in and will address the proposals for party under old business.

David called for a vote on PPD's. His vote from the captains at this time removed us from using PPD's and Power Rating will be discussed for next season.

Old Business:

Break Room was voted on for party. Jessica made motion to accept and Lori seconded that motion. A vote was cast and the majority ruled. Break Room on November. 8th for playoffs in the morning and party starting between 2-3.

The proposal for paying officers dues each season was addressed. This was a proposal that had been addressed many seasons ago and had never been voted on. We ALL were in agreement to deny this proposal and it is now a mute issue.

We need **written proposal** for Power Ratings to be used next season to be submitted at our first meeting of the Winter League.

New Business: David protested his loss of 3 points for not having a team representative at the last meeting and felt he should get his points back since he had called and asked Tami to represent him. As you all know it was ME, Marty Foote that told her I did not think she could do that since she was not on his team, and was not signed up on any team

this season. David was upset about this and wanted to protest this even though, since the rule was administered, we have never had anyone protest, because most people in the league realize that it was a given that the Team Representative actually meant someone from the team or I guess it would have read League Representative. It was voted on and passed that he could have his 3 points back. Bringing into the question of this area being well defined so that there is not a misunderstanding again. **Also, David needs to submit his protest in writing in the future as stated in the rules of the TDA.**

Aiken – Augusta Shoot out. Saturday before Thanksgiving, this would be November 21st. It will be held at the 3200 VFW. Please notify your team members and have them let Aaron know if you want to participate. Aaron will be posting notifications about this on the Website. He and David will schedule this together.

The following teams did not have a TEAM representative at the meeting and will receive 5 points off of their score.

Double D's, Arrowshooters, and Here 4 Beer. Cameltoes VIX will receive 3 points off their score. Normally in the past it was understood that you must have a member of your team to represent you, not just a member of the league. Any one who is registered on your team can represent the team at the meeting if the Captain or Co-Captain can not make it. Since there seems to be some question about this we must clarify this in the rules and regulations since some people do not agree with policy. This needs to be addressed at our first meeting in the Winter Season. This was our understood policy up till now and we must have the revision so that we do not have this problem addressed again.
